## **St Augustine South Reflections**

Many neighbors found the late July heat dome unbearbly hot. We had been spared the June dome that roasted states north of us, but were not so lucky at the end of July. Although there have been some heavy rain storms keeping the grass green, I noticed

many trees showing signs of heat shock. My own Chickasaw plum shed its leaves in July, as did my saucer magnolia, and many natives including American beautyberry wilted during the hot days. It's good to refill birdbaths and saucers of water for wildlife frequently during hot summer days. I often throw in a large bucket of ice on summer afternoons

But I no longer leave the water from day to day after getting Cuban tree frog tadpoles in my birdbath. The Cubans are invasive and both crowd out our native tree frogs and eat our natives. Female Cuban treefrog adults grow up to 5 inches in body length, much larger than native Florida treefrogs, and have enormous toe pads that are larger than toepads of native treefrogs in Florida. The females lay hundreds of eggs with

a "frog spawn" jelly coat where as our natives only lay a few eggs – a score at the most – at any one time.

So when my bird bath was teeming with tadpoles, I knew they were Cubans and poured them onto the garden for critters to eat. University of Florida Institute of Food and Agricultural Sciences has several publications on Cuban tree frogs, including reasons for and how to rid our gardens of tree frogs. From time to time, I get called to "rescue" ducks that have been abandoned in unsuitable places. Our volunteer wild-life rehabbers are not allowed under Florida law to rehab domestic ducks like the white pekin ducks that are often abandoned

on retention ponds from late spring and over the summer months. Pekins have been domesticated for nearly six thousand years and have lost the ability to fly, and the skills to evade predators and survive in the wild. They are essentially condemned to a cruel end as a meal for a predator when dumped on a pond, even if they look pretty and happy for a few weeks or months.

Our native wild ducks are much better equiped for life on a pond. The majority of abondoned pekins are drakes that are unwanted as they don't produce eggs, or their numbers are in disproportion to the owner's female ducks. Traditionally, Florida homesteaders kept a flock of ducks both for eggs and meat. Females were an asset, and surplus drakes went into

the cooking pot. In current times, backyard ducks are more pets than livestock and their

owners prefer to abandon drakes on ponds to filling their freezer. A quick, humane end is, to my thinking, greatly perferable to the terror and pain of becoming dinner for a hungry raccoon. Another issue is the sale of "Easter ducklings" many of which do not go to secure back garden coops and pens, but are kept in a basket in the house. Yet ducklings grow rapidly and these in-home pet ducks are unwanted after 5 or 6 weeks, when they are no longer little yellow fluffies, but full grown white juvenile pekins.

I see an uptick in abandoned ducks 6 weeks after Easter. Some are female: for them I can find adoptive homes; but there are always more drakes and they are very dfficult to rehome. I would like Tractor Supply to stop selling Easter Ducklings. If they changed their policy and made the minimum purchase 5 or 6 ducklings, rather than the current two, those who are not serious backyard or small homestead duck keepers would likely not make frivolous purchases of vulnerable little lives to amuse their children for a short while.



will allow us to continue this tradition.



## 10 Things Medicare Doesn't Cover Part 2

This is Part 2 of this article regarding how Medicare covers most health care needs for Medicare-eligible participants, from hospital care and doctor visits to lab tests and surgery. But some necessities — and desires — aren't part of the program. Here's how you might pay for them.

6. No massage therapy, even for chronic pain

Original Medicare doesn't cover massage therapy, often used to help reduce chronic pain. Research suggests it may provide short-term, but not long-term, relief.

For pain management, Medicare does cover chiropractic care in certain limited circumstances (see above) as well as physical and occupational therapy when a doctor prescribes it.

Some Medicare Advantage plans might cover some massage therapy. It's best to call your plan to find out.

Solution: Ask your health care provider to recommend a pain management strategy that Medicare will pay for. If you are set on getting massage therapy, you'll likely have to pay for it yourself.

7. You're on your own for a podiatrist's routine foot care

Routine medical care for feet, such as callus removal, is not covered. Medicare Part B does cover foot exams or treatment related to nerve damage because of diabetes or foot injuries or ailments, such as bunions, hammertoe and heel spurs.

Solution: If you face these costs, you may want to set up a separate savings

8. Add insurance to your dream vacation overseas
Original Medicare and most Medicare Advantage plans offer virtually no coverage for medical costs outside the U.S.

Solution: Some Medigap policies cover certain overseas medical costs, typically paying 80 percent of the billed charges for specific medically necessary emergency care you receive outside of the U.S. after a \$250 annual deductible. Medigap's foreign travel emergency coverage has a lifetime limit of \$50,000.

In addition, some travel insurance policies provide basic health care coverage but they may exclude preexisting conditions, so check the fine print. Finally, consider medical evacuation, also known as medevac, insurance for adventures abroad. It will help pay to transport you to a nearby medical facility or back home to the U.S. in case of emergency.

9. Long-term care often comes out of your pocket

Medicare pays for limited stays in rehab facilities — for example, if you have a hip replacement and need inpatient physical therapy for several weeks. But if you need long-term help with the activities of daily living in a nursing home or assisted living center, you will have to pay the costs yourself.

Nursing homes average about \$90,000 a year for a semiprivate room and more than \$100,000 for a private room. Costs vary based on where you live and what

place you choose.

Solution: Lots of decisions go into planning for nursing home care. Some people buy long-term care insurance, and others include these potential costs in their retirement plans.

Veterans may have access to some long-term care programs. For those with limited income and savings, Medicaid might help fill in the gaps.

10. If you want concierge care, you'll pay extra

Some physicians and their practices require a membership fee. They advertise that this makes them more responsive and available to their patients.

The fees, which can run in the thousands of dollars a year, vary depending on the concierge or boutique practice. Medicare will not cover these fees.

Once you've paid that fee, if your doctor participates in Medicare, that physician must offer all the services Medicare does with the same copays and coinsurance

Solution: You can either pay the fee or find another doctor. You might talk to your physician about the terms of when you have to pay. Some states have laws that provide consumer protections for these arrangements.
