
#### St. Augustine South Reflections

I really should not be surprised as St Augustine South is in Florida. Yet, there I was on November 1 this year shaking my head in disbelief. While many neighbors had Halloween decorations in their front yards, others had begun to put up their Christmas decorations. For years, the tradition observed has been Holiday lights and

decorations appearing immediately after Thanksgiving. This was as regular as clockwork. But now, we are so anxious to cheer up the surfeit of cold, gray, windy days we have been experiencing, that the priority is to get out the Holiday decorations at the beginning of November. My own family tradition is to trim our tree on Christmas Eve and take down and pack away all the decorations on 12th Night. 

The talents and passions of each and every board member emerged and came into focus. The staff juggled their many duties with the day-to-day challenges of working in a construction zone. We pushed our contractors hard but they were all committed to seeing the project to completion.

We received tremendous support from the greater community as well including: The Classic Car Museum, Ameris Bank, Herbie Wiles Insurance and the members of the Chamber of Commerce who came out in force to support our Ribbon Cutting Ceremony. Most importantly, we received the support of our residents, who cheered us on and lifted our spirits every day.

While the Situation Room has long been dismantled and the files have been properly stored, I will forever cherish the teamwork and the dedication that brought us to the Grand Opening. Thank you all for your collective efforts to turn the tired and water-logged Riverview Club into the crown jewel of The Shores and dare I say, a new destination for St. Augustine residents and visitors for years to come! These meetings provide an excellent opportunity to get to know the elected representatives, mingle with Democratic candidates and socialize with our Democratic neighbors.



Donating one non-perishable, unexpired food item will remove \$2 of fines from a patron's library record. 



#### St. Johns County Launches New Rental Assistance Program

As the holidays approach, the U.S. Department of the Treasury has provided St. Johns County with \$2,150,000 of emergency rental assistance to help low-income renters catch up on past due rent and utilities, specifically as they recover from housing instability experienced during and after the pandemic.

St. Johns County Emergency Rental Assistance (SJC ERA) can provide qualified households with up to 18 months of total assistance, including back rent and utilities, and up to three months of future assistance. Qualified renters in the middle of an eviction proceeding get expedited assistance. Registration for the program is open for tenants and landlords at www.sjc-era.com.

St. Johns County engaged Capital Access Inc., a grants management consultant, to serve as program manager for SJC ERA. Capital Access processed 18,000 grants for rent, mortgage, and small business assistance during the pandemic for counties and cities in Florida and Pennsylvania.

Capital Access provides a team of experienced case managers who can help tenants and landlords throughout the application process. Online applications are available by going to

"Once an application is complete and the grant agreement is executed, we can issue payment directly to the landlord within 48 hours," Capital Access CEO Jeremey Newberg said. "Many renters still face financial challenges that started during the pandemic. SJC ERA can help them catch up on past-due rent and utilities. Landlords benefit because they can recover past due rent, which helps the overall St. Johns County economy."

The County set a goal to expend 100% of the rental assistance grants by the end of 2023. Tenants and landlords are encouraged to apply at www.sjc-era.com while funds remain

How the program works:

- SJC ERA will pay for past-due rent and utilities and up to three months of future eligible housing/utilities expenses, totaling up to 18 months of assistance for qualifying applicants. Qualifying past-due rent can go as far back as April 1, 2020.



  - Applicants get the highest priority for processing if:
  - The total household income is less than 50% AMI;
- Households with a person unemployed for at least 90 days before the date of the complete application;
  - Currently in an eviction proceeding;

Residents are encouraged to apply early as funds are limited. Application Specialists are available to assist. People with language and/or physical challenges can request assistance with application submission. Residents are encouraged to apply now as funds are limited. #### City of St. Augustine Parking rate increases with the new Budget

Enforcement hours expanded, including Sundays

During its FY24 budget discussions, the St. Augustine City Commission voted to approve increased parking rates for the Historic Downtown Parking Facility (parking garage) and extending the hours of parking enforcement throughout the City.

Rates for the parking garage will increase from \$15 to \$20 per vehicle, per entry, during peak parking times. However, there will be changes to the hours in which certain special rates will apply. For example, after 5:00pm, during offpeak times, the rate will drop to \$5 per vehicle, per entry.

The peak and off-peak times are as follows:

7:00am - 5:00pmPeak parking times:

Off-peak parking times: 5:00pm – 9:00pm

The off-peak parking times rate of \$5 will not be applied during special festivals, Nights of Lights, and on days when free satellite parking and shuttle services are operating. All parking rates for any registered St. Johns County resident using the ParkNow Card will remain the same.

Hours of enforcement for City-managed parking lots and street parking spaces will be extended citywide from 5:00pm to 9:00pm and will include Sundays from 1:00pm to 9:00pm.





#### What is **Blood Flow Restriction**

exercise is not new. In fact, as with many treatments, even penicillin, it was discovered by accident. Yoshiaki Sato, a Japanese exercise enthusiast noticed swelling in his leg after prolonged kneeling and recognized the same feeling in his legs he experienced while working out. From this experience, he developed what he called KAATSU, or "training with added pressure". He applied these principles to his own rehabilitation in 1973 after experiencing severe injury to his legs and made a wonderful recovery.

Fast forwarding, his methods became popular in the body building community of the 1970's, which led to preliminary research up through the 90's. This was followed by a research explosion in the early 2000's as the technique increased in popularity. It gained increased notoriety from professional sports and related

media coverage.

for us today, the Fortunately, research has produced a sizeable body of knowledge, and brought more consistency to equipment standards and treatment protocols. And although BFR is not a cure-all, nothing is, there is a strong scientific basis for using BFR treatments, not just in sports but also in rehabilitation.

Muscle strength and hypertrophy, or any tissue, depends on progressive loading. Targeted tissue is challenged loads increasing producing mechanical tension, muscle microtrauma and metabolic stress. In return, the body adapts with increased density or increased strength. Historically, progressive loading meant using high loads (>80% 1 max rep or 80% of what can be lifted 1x), repeating to the point of fatigue/failure. But higher loads have also meant injury to both the healthy athlete and those trying to heal through rehabilitation. But what if the same results could be achieved, generating the same positive adaptations using much lower loads? If applied correctly, BFR, using exercise loads 20-30% 1 max rep, can produce similar results - muscle fatigue, increased metabolites, and increased growth hormone – with less chance of tissue damage.

Without getting too technical, but in case you were curious, these results are

Blood Flow Restriction, or BFR achieved by partially and temporarily restricting blood flow with pressurized The restriction promotes an inflammatory response similarly seen using heavy weights. The inflammatory response causes the production of myokines, which are cytokines produced in skeletal muscle. One specific cytokine, interleukin 6 (IL-6), is responsible for the acute phase of protein synthesis. And what is of particular interest, muscle damage is not required to bring about increased levels of IL-6. Additionally, it is hypothesized that muscle fatigue from BFR triggers a higher motor unit recruitment earlier in the exercise, which results in greater muscle activation, similarly produced when using higher

> What are the downside and safety considerations? Your therapists should do a thorough examination, including a medical history, to ensure BFR is indicated for your condition. But if indicated and if applied correctly, the most common side effect is muscle soreness as with most types of exercise.

> BFR is a proven training option for the athlete but is also making waves in rehabilitation. It may be a viable tool to help you with your recovery and healing.
